

MINUTES OF THE REGULAR MEETING OF THE BOARD
OF TRUSTEES OF NORTH WHITE SCHOOL CORPORATION

The Board of Trustees, North White School Corporation met in Regular session on Monday, November 8, 2010 at 7:00 p.m. in the Gymnasium of Reynolds Elementary School at 401 West 2nd Street, Reynolds, Indiana according to Indiana Code 10-5-3-2, Public Law 57, and the rules of the Board. 1. Mr. Mattix called the regular meeting to order.
 - A. The Pledge of Allegiance followed.
 - B. Mr. Mattix recognized a Quorum.
 - C. Mr. Mattix asked if there were any additions or corrections to the minutes of the regular meeting on October 11, 2010. Mr. Pogue made a motion to approve these minutes. Mrs. Bossung seconded and the motion carried 7-0.
 - D. Claims and payrolls were presented to the board and discussed. Mrs. Ruemler gave the board a summary of several claims.

Mr. Allen moved to accept these recommendations. Mr. Pogue seconded and the motion carried 7-0.

D. Mr. Mattix recommended that the Board adopt the resolution for Authorizing Tax Anticipation Time Warrants, Series 2011. See "Exhibit A".

Mr. Culross moved to accept this recommendation. Mr. Allen seconded and the motion carried 7-0.

6. Guests of the board – None

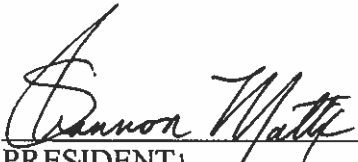
7. For second hearing of patrons, Mr. Mattix asked if there were any patrons in attendance who wished to be heard.

Patron Peggy Johns addressed concerns in special education with Logansport Area Joint Special Services Cooperative (LAJSSC). Mrs. Johns feels like North White is not getting what it's paying for from the cooperative such as one-on-one instructional time and teacher training. She presented pamphlets from INSOURCE, an Indiana parent resource for parents with special needs children. Mr. Eccles noted that Mrs. Johns' concerns have been heard and that the Board is seeking action.

Mr. Eccles informed the Board that during the school year, unless otherwise noted, the regular school board meetings will be held in the high school library.

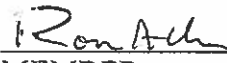

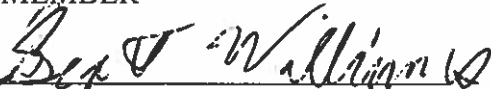

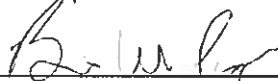
