

MINUTES OF THE REGULAR MEETING OF THE BOARD
OF TRUSTEES OF NORTH WHITE SCHOOL CORPORATION

The Board of Trustees, North White School Corporation met in Regular session on Monday, November 11, 2019 at 7:00 p.m. in the office of the Superintendent at 402 E. Broadway, Monon, Indiana according to Indiana Code 10-5-3-2, Public Law 57, and the rules of the Board. Board members present were Jim White, Shannon Mattix, Rebecca Princell, Terry Smith, Joshua Robertson and Ricki Westerhouse. Board member not present was Scott Williams. Also present were Nicholas G. Call to Order

Mr. White called the regular meeting to order.

- 1.1 The Pledge of Allegiance followed, a Quorum was recognized and visitors were welcomed to the meeting.
- 1.2 Mr. White asked if there were any additions or corrections to the minutes of the October 14, 2019 Regular Meeting and the November 5, 2019 Public Hearing. These meeting minutes were approved, with no objections, by unanimous consent.
- 1.3 Claims and payrolls were presented to the Board and discussed. Mr. White recommended that the Board approve to pay claims 11128096 through and including 11128121. The claims and payrolls were approved, with no objections, by unanimous consent.
- 1.4 Mr. White asked if there were any emergency additions to the agenda. Hearing none, the meeting proceeded.
- 1.5 Student Recognitions

Mrs. Owens introduced the November "Student of the Month" at the North White Elementary School. She introduced Weston Dahlenburg who is in the second grade. Weston is the son of Daniel and Ashley Dahlenburg. Mrs. Owens, Weston's teacher, nominated him for this award.

Mrs. Brown introduced the November "Student of the Month" at the North White Middle School. She introduced Madyson Westerhouse who is in the seventh grade. Madyson is the daughter of Kyle and Christina Westerhouse. Mrs. Brown, Madyson's teacher, nominated her for this award.

Dr. Maas introduced the November "Student of the Month" at the North White High School. He introduced Tammy Howard who is in the tenth grade. Tammy is the daughter of Dawn Howard. Dr. Maas, Tammy's teacher, nominated her for this award.

2. Mr. White asked if there were any patrons in attendance who wished to be heard. Patron, Mr. Jim Culross read a lengthy letter to endorse the rally "Red for Ed" on November 19, 2019. Hearing no other comments, the meeting proceeded.
3. Reports/Action Items
 - 3.1 Mr. White asked if there were any patrons in attendance who had any questions/comments on the 2019-2021 Teacher Agreement with the North White Classroom Teacher Association (NWCTA) as presented at the November 5, 2019 Public Hearing. Hearing none, the meeting proceeded.
 - 3.2 Mr. White recommended that the Board approve the compensation as follows: a. the 2019-2021 Teacher Agreement as presented, retroactive as of July 1, 2019 with the date of pay December 6, 2019. Ms. Princell moved to approve this recommendation. Mrs. Westerhouse seconded and the motion carried 6-0. b. Mr. White recommended that the Board approve the 2% compensation for Mr. Woodcock and Mr. Van Der Aa (only 2 administrators were eligible for raises), retroactive as of July 1, 2019 with the date of pay December 6, 2019. Mrs. Westerhouse moved to approve this recommendation. Ms. Princell seconded and the motion carried 6-0. c. Mr. White recommended that the Board approve the Classified staff compensation as presented, retroactive on the payroll period November 18-November 29, 2019 with the date of pay December 6, 2019. In addition, the Classified staff will receive a \$500 stipend for those who reach a 5 year work milestone (ie 5, 10, 15, etc). Ms. Princell moved to approve this recommendation. Mr. Mattix seconded and the motion carried 5-0, Mr. Smith abstained.
 - 3.3 Mr. White recommended that the Board approve the modified 2019-2020 school calendar as presented. He asked that the calendar reflect November 19, 2019 as a no school day for the "Red for Ed" rally in Indianapolis and that January 24, 2020 will be the rescheduled school day; snow day dates will be February 14, 2020; March 13, 2020 and May 22, 2020. Mr. Mattix moved to approve these changes. Mr. Robertson seconded and the motion carried 6-0.

3.4 Mr. White recommended that the Board approve pursuing Grants beneficial to North White School Corporation. Mr. Smith moved to approve these recommendations. Ms. Princell seconded and the motion carried 6-0
