 - A. Mr. Mattix asked for emergency additions to the agenda. B. D. Other

Mr. Mattix presented to the Board a letter from Suzy Karberg, White County Learning Lab Director, for a 3.5% increase for Kim Hornback, effective January 1, 2011. Mr. Mattix asked the Board for a motion to accept this increase.

The motion carried as follows for the 3.5 % increase 2-4 with 1 abstaining. Mr. Worrell and Mr. Allen voted for the increase. Mr. Mattix, Mrs. Bossung, Mr. Williams and Mr. Pogue were opposed. Mr. Culross abstained.

Mr. Eccles recommended that the Board President and the Board Secretary sign the Authorization for Alternative Services & Private Residential School Placements. See "Exhibit A".

Mr. Mattix moved to approve this recommendation. Mr. Pogue seconded and the motion carried 7-0.

Mr. Eccles informed the Board that every year at this time a Board of Finance must be established. Mr. Mattix agreed to continue on as President of the Board of Finance for 2011. He also moved to appoint Mr. Worrell as Secretary of the Board of Finance for 2011. Mr. Pogue seconded and the motion carried 7-0.
