MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF NORTH WHITE SCHOOL CORPORATION

The Board of Trustees, North White School Corporation met in Regular session on Monday, October 14, 2019 at 7:00 p.m. in the office of the Superintendent at 402 E. Broadway, Monon, Indiana according to Indiana Code 10-5-3-2, Public Law 57, and the rules of the Board. Call to Order

Mr. White called the regular meeting to order.

- 1.1 The Pledge of Allegiance followed, a Quorum was recognized and visitors were welcomed to the meeting.
- 1.2 Mr. White asked if there were any additions or corrections to the minutes of the September 9th Public Hearing, Regular Meeting, Executive Session and the October 7th Public Hearing. These meeting minutes were approved with no objections, by unanimous consent.
- 1.3 Claims and payrolls were presented to the Board and discussed. Mr. White recommended that the Board approve to pay claims 11127890 through and including 11127943. The claims and payrolls were approved with no objections, by unanimous consent.
- 1.4 Mr. White asked if there were any emergency additions to the agenda. Hearing none, the meeting proceeded.

- 3.1 Principal Report Mr. Hawk, NWES Principal reported on the following:
 - a. After school tutoring will begin on Tuesday, October 15.
 - b. Literacy/EL/STEM night was a great success.
 - c. For Fire Prevention week the Firemen visited classrooms on Friday, October 11.
- 3.2 Principal Report Mr. VanDerAa, NWMS-HS Principal, reported on the following: a. After school tutoring is going well. b. the Form 30A "CTE funds" were submitted. c. he spoke on the WIDA assessments for use to determine the language level of English Language Learners (ELL) entering school. He also spoke of the proposed State ELL mandate from the IDOE ELL schools/teachers and the phase-in, timeline of July 2020 through July 2022.

3.3 Transportation and Facilities

Mr. Cook, transportation/building and grounds director, informed the Board On Friday, October 11, the solar system went online and it did produce 50% of power. On Saturday, October 12 it was at full power (100%). He also mentioned that students and staff will learn about the power of solar using an interactive tool for the classrooms.

3.4 Superintendent Report

Dr. Klitzman expressed his excitement on the power of solar as an educational learning tool in addition to the potential cost savings. He reiterated that the timeline for the State ELL mandate for teachers is three years in the future and not Legislative. He also stated there are already teacher shortages in several areas whereby schools have difficulty finding licensed teachers. This request would place a substantial burden on schools and needs to be modified.

Mr. Smith seconded and the motion carried 7-0. Dr. Klitzman stated it has been a pleasure to work at North White these past 5 months and that North White has great people in all areas to work with.
