- 1. Mr. Mattix called the regular meeting to order.
 - A. The Pledge of Allegiance followed.
 - B. Mr. Mattix recognized a Quorum.
 - C. Mr. Mattix asked if there were any additions or corrections to the minutes of the executive session, the regular meeting and the work session on March 14, 2011. Mr. Pogue made a motion to approve these minutes. Mr. Culross seconded and the motion carried 7-0.
 - D. Claims and payrolls were presented to the board and discussed. Mrs. Ruemler gave the board a summary of several claims.

4. Old Business

Mr. Mattix recommended that the Board adopt the updated NEOLA polices.

Mr. Worrell moved to adopt these policies. Mrs. Bossung seconded and the motion carried 7-0.

New Business

A. Mr. Mattix asked for emergency additions to the agenda. Mr. Eccles asked the Board to add (under personnel) approve the resignation of Tammy Craig as Drama Sponsor and to add (under new business) item D. Other on the Public Agenda.

Mr. Mattix moved to approve these additions. Mr. Pogue seconded and the motion carried 7-0.

B. Mr. Cook, transportation/building and grounds director, informed the Board that the insurance company settled on the snow damage that was done to the gutters and snow guards at the Auditorium. The gutters and snow guards will be installed this week.

C. Personnel

Mr. Mattix recommended that the Board approve the resignation of Tina Segal as Treasurer for North White Jr-Sr High School, effective April 15, 2011 and the resignation of Tammy Craig as Drama Sponsor for the 2010-2011 school year, effective April 11, 2011.

Mrs. Bossung moved to accept these recommendations. Mr. Allen seconded and the motion carried 6-1 with Mr. Worrell opposing.

Mr. Mattix recommended that the Board approve the hiring of Jennifer Rendant as Drama Sponsor for the remainder of the 2010-2011 school year, effective April 11, 2011.

Mrs. Bossung moved to accept this recommendation. Mr. Allen seconded and the motion carried 7-0.

D. Other

Mr. Mattix recommended that the Board approve the request by Mr. McKee regarding the requirements to attend the Prom. See "Exhibit A".

Mr. Allen moved to approve this recommendation. Mrs. Bossung seconded and the motion carried 7-0.

Mrs. Hay presented to the Board the recommendations for adopting textbooks for Science/Health Education for K-12 to begin in 2011-2012, for six (6) years (through 2016-2017) and for Mathematics for K-12 to begin in 2011-2012, for five (5) years (through 2015-2016). Mr. Mattix recommended that the Board approve these recommendations. See "Exhibit B".

Mr. Culross moved to approve these recommendations. Mr. Worrell seconded and the motion carried 7-0.

Mr. Eccles spoke on the purchasing of a new student data management system for the corporation. He asked the Board to approve the use of \$18,804 from the Rainy Day Fund for purchasing this system. See "Exhibit C".

Mr. Pogue moved to approve the use of the Rainy Day Fund. Mr. Worrell seconded and the motion carried 4-3 with Mr. Mattix, Mr. Williams and Mr. Allen opposed.

Mr. Eccles recommended that the Board approve the Service Agreement with Administrator Assistance. Administrator Assistance will prepare the 2012 Budget for the 2011-2012 school year. The preparation fee for this service is a flat fee of \$5100. See "Exhibit D".

Mr. Worrell moved to approve this recommendation. Mr. Culross seconded and the motion carried 7-0.

Mr. Mattix informed the Board that Mrs. Wireman is requesting permission to advertise for cafeteria milk and bread bids for the 2011-2012 school year. Mr. Mattix recommended the Board approve this request.

Mr. Williams moved to approve this recommendation. Mr. Allen seconded and the motion carried 7-0.

Mr. Mattix recommended that the Board approve the 2011 summer school schedule and the hiring of necessary personnel.

Mr. Williams moved to approve this recommendation. Mrs. Bossung seconded and the motion carried 7-0.

Mr. Eccles addressed the reduction of the following positions for the 2011-2012 school year; (1) section of kindergarten, first grade, second grade and high school English. He explained that class sizes will be increased in those classes but are still estimated to be less than 22 students per class. Mr. Mattix asked Board members if they had any comments or questions. Mr. Allen cited his reasons for not reducing the following positions. Mr. Mattix asked if there is a motion on the floor to reduce the positions listed.

Mr. Pogue moved to approve these reduced positions. Mrs. Bossung seconded and the motion carried 5-2 with Mr. Allen and Mr. Williams opposed.

Mr. Mattix asked for a motion on the floor to begin the discussions on the closing of Buffalo and Reynolds Elementary Schools. Mr. Culross moved to begin discussions on the closing of the buildings. Mr. Worrell seconded. He then asked the Board members to read their statements and to announce their votes individually on the closing of Buffalo and Reynolds Elementary Schools.

The closing of Buffalo and Reynolds Elementary Schools passes with a 5-2 vote. Mr. Allen and Mr. Williams were opposed. Mr. Mattix, Mrs. Bossung, Mr. Pogue, Mr. Culross and Mr. Worrell voted in favor of closing the buildings.

Mr. Eccles addressed the North White School Corporation campus reconfiguration as follows: kindergarten through third grade will be housed at the current Monon Elementary building; fourth through sixth grade will be housed across the street in the old middle school end of the building.
