- 1. Mr. Mattix called the regular meeting to order.
 - A. The Pledge of Allegiance followed.
 - B. Mr. Mattix recognized a Quorum.

Two school corporations will be selected at the sole discretion of the IDOE and will be awarded \$40,000 in September 2012, \$40,000 in September of 2013, and \$20,000 in September of 2014 if goals are met.
