# MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF NORTH WHITE SCHOOL CORPORATION

  - 1.2 Mr. Pogue recognized a Quorum.

Dr. Gremaux recommended that the Board appoint Rebecca Princell to fill the school board vacancy. Mr. White moved to accept this recommendation and Mr. Williams seconded and the motion carried 6-0.

Mrs. Ruemler administered the Oath of Office and swore in new board member Rebecca Princell.

- 3.3 Mr. Pogue recommended that the Board approve the Resolution Initiating an Amended and Restated Plan of Organization Changing the Governing Body Composition and Manner of Election of the NW School Board of Trustees. Mr. White moved to approve this recommendation. Mr. Williams seconded and the motion carried 7-0. See "Exhibit A".
- 3.4 Mr. Pogue recommended that the Board approve the Memorandum of Agreement between NWSC and TMC Migrant Seasonal Head Start. TMC provides center-based, full-day Head Start services to eligible migrant children and their families. Mr. White moved to approve this recommendation. Mr. Culross seconded and the motion carried 7-0. See "Exhibit B".

- 3.5 Mr. Pogue recommended that the Board approve the Service Agreement with Administrator Assistance. Administrator Assistance will prepare the 2017 budget. The preparation fee for this is a flat fee of \$5100. Mr. White moved to approve this recommendation. Mr. Williams seconded and the motion carried 7-0. See "Exhibit C".
