- 3.2 Mr. Pogue recommended that the Board approve the second reading of the NEOLA Special Release The Edgar Collection (Indiana). Mr. White moved to approve these recommendations. Mr. Culross seconded and the motion carried 5-0-1 with Mr. Mattix opposed.
- 3.3 Mr. Pogue recommended that the Board approve Mr. Richard Lynn to replace Mr. Mark Bentlage on the White County Area Plan Commission. Mr. Lynn will complete the remainder of Mr. Bentlage's term ending the first Monday in January 2020. Mr. White moved to approve this recommendation. Mr. Culross seconded and the motion carried 6-0. See "Exhibit A".
 - 3.4 Mr. Pogue recommended that the Board approve Deyo/Stone Associates, Inc. to conduct an appraisal of North White property. Mr. White moved to approve this recommendation. Mr. Williams seconded and the motion carried 6-0.

- 3.5 Mr. Pogue recommended that the Board approve the permission to advertise for the 2017 Budget. Mr. Culross moved to approve this recommendation. Mr. Williams seconded and the motion carried 6-0.
- 3.6 Mr. Pogue recommended that the Board approve the 2017-18 NWSC calendar. Mr. Williams moved to approve this recommendation. Mr. White seconded and the motion carried 6-0. See "Exhibit B".

Discussion/Information

- 4.1 Transportation and Facilities update Mr. Cook, transportation/building and grounds director, informed the Board that the facilities are close to being ready for the start of school on August 12, 2016.
- 4.2 Dr. Gremaux introduced Pooja Shrestha with Umbaugh and Associates. Pooja presented and explained the historical Debt Service Budget, Levy and Tax Rate(s). She also explained the low tax rate to taxpayer's in the year 2015 was impacted by House Enrolled Act 1062, which reduced property tax rates, for that year, only to have them go back up for the 2016 cycle. She pointed out that the 2016 tax rates are actually lower than the past years of 2011, 2012, 2013 with the exception of 2014. With current projects completed, the current tax rate should be consistent in the coming years for property owners in the North White School Corporation. See "Exhibit C".
- 4.3 Mr. Little, board attorney, discussed the resolution to transition the Monon Corp seat currently held by Rebecca Princell to an at-large position. During the recent process, IDOE rejected the plan due to errors in the advertisement. Mr. Little advised after the 120 days to start the process again and he will look at any additional requirement that may be needed by law. The plan can still be submitted, it will not be reflective in this election cycle but rather for next election for this seat, November of 2018 and the seating date of next term January of 2019.
