- 3.2 Mr. Pogue recommended that the Board approve a donation from Jim White for electricity usage for the 4-H booth at the White County fair. Mr. Williams moved to approve this recommendation. Ms. Princell seconded and the motion carried 6-0.
- 3.3 Mr. Pogue recommended that the Board approve the revised School Board Policy 2271- College, University and Online Programs. Mr. Williams moved to approve this recommendation. Mr. White seconded and the motion carried 6-0. See "Exhibit A".
- 3.4 Mr. Pogue recommended that the Board approve the NWSC Grading Committee recommendations on the following: Grade Point Average Scale, Weighted Grade System, Final Exam Policy, Final Exam Weighting, Valedictorian and Salutatorian/Latin System and Grade and Assessments. Mr. White moved to approve these recommendations. Mr. Culross seconded and the motion carried 6-0. See "Exhibit B".
- 3.5 Mr. Pogue recommended that the Board approve the Athletic Handbook changes for the 2017-2018 school year. Mr. Culross moved to approve these recommendations. Mr. White seconded and the motion carried 4-2 with Mr. Smith and Mr. Williams opposed. See "Exhibit C".
- 3.6 Mr. Pogue recommended that the Board approve the School Board Policy 8500 Food Services. Mr. White moved to approve this recommendation. Mr. Culross seconded and the motion carried 5-1 with Mr. Williams opposed. See "Exhibit D".
- 3.7 Mr. Pogue recommended that the Board approve the Memorandum of Understanding with Four County Counseling Center for assignment of clinical service provider(s) for NWSC for the 2017-2018 school year. Mr. Culross moved to approve this recommendation. Mr. Williams seconded and the motion carried 6-0. See "Exhibit E".
- 3.8 Mr. Pogue recommended that the Board approve the e-Funds for Schools (Electronic Funds Transfer Agreement) with Magic-Wrighter, Inc. The e-Funds will enable our parents to pay for lunches, textbooks and other additional fees online. Mr. Williams moved to approve this recommendation. Mr. Culross seconded and the motion carried 6-0. See "Exhibit F".

- 3.9 Mr. Pogue recommended that the Board approve the Non-certified staff salary increase of \$.20 plus the scheduled increment. This increase is for current Non-certified staff prior to July 1, 2017. Mr. White moved to approve this recommendation. Mr. Williams seconded and the motion carried 5-1, Mr. Smith, abstained.
- 3.10 Mr. Pogue recommended that the Board approve to pay for Expanded Criminal History checks on 20% of current employees starting with the most tenured employees and 20% each year over the next 5 years until all existing employees have been screened. The requirements for the Expanded Criminal History checks is the result of Indiana HB1079, effective July 1, 2017. Mr. Williams moved to approve this recommendation. Mr. White seconded and the motion carried 6-0.
- 4. Discussion/Information
 - 4.1 Mr. Cook, transportation/building and grounds director, had nothing to report.
 - 4.2 Discussion was held on the Professional Services Agreement for Athletic Trainer Services by and between Franciscan Alliance, Inc. d/b/a Franciscan Health Lafayette and North White Junior-Senior High School. Mr. Woodcock presented this Agreement and requested that the NW School Board pay (50%) of the partnership fee of \$4500. The term of this Agreement will be two years, beginning on August 1, 2017 and ending on July 31, 2019. Mr. Culross moved to approve this request. Mr. Smith seconded and the motion carried 6-0.
