# MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF NORTH WHITE SCHOOL CORPORATION

The Board of Trustees, North White School Corporation met in Regular session on Monday, September 11, 2017 following the adjournment of the Public Hearing in the office of the Superintendent at 402 E. Broadway, Monon, Indiana according to Indiana Code 10-5-3-2, Public Law 57, and the rules of the Board. - Call to Order
  - Mr. Pogue called the regular meeting to order.
  - 1.1 The Pledge of Allegiance followed.
  - 1.2 Mr. Pogue recognized a Quorum.
  - 1.3 Mr. Pogue asked if there were any additions or corrections to the minutes of the work session, the regular meeting and the executive session on August 14, 2017 and the executive session's on August 23 and August 30, 2017.
