- 3.2 Mr. White recommended that the Board approve the second reading and the adoption of NEOLA Volume 30, Number 2 April 2018. Mr. Pogue moved to approve this recommendation. Ms. Princell seconded and the motion carried 6-1, Mr. Mattix opposed.

  - 3.10 Mr. White recommended that the Board approve the purchase of Houghton Mifflin Harcourt System 44. System 44 is a reading intervention program that will be utilized in assisting our newest Spanish speaking students to

acquire the appropriate skills for beginning readers. The NESP grant funds will cover the cost of this program. Mr. Culross moved to approve this recommendation. Ms. Princell seconded and the motion carried 6-1, Mr. Smith opposed.

- 3.11 Mr. White recommended that the Board approve the Bauer Family Resources Interagency Agreement. This agreement is to outline the use of facilities and responsibilities of Bauer and NWSC. Bauer runs a Pre-K program in our M-HS each year. There is no cost to house the program in our schools. Mr. Culross moved to approve this recommendation. Ms. Princell seconded and the motion carried 7-0. See "Exhibit E
- 3.12 Mr. White recommended that the Board approve the change to the previously adopted Inter-Local Agreement for School Resource Officer between NWSC and the Town of Monon. The Town of Monon asked to remove the liability from NWSC. The Town of Monon indemnifies NWSC against a loss resulting from an injury to a person caused by the SRO if the loss was the result of misfeasance, malfeasance or nonfeasance in connection with the use of the officer's weapon. This change is located on page 4, number 12. Mr. Williams moved to approve this recommendation. Ms. Princell seconded and the motion carried 5-2, Mr. Culross and Mr. Mattix opposed. See "Exhibit F".
