

# 2017 School Corporation Annual Performance Report (APR)

## General Explanations

The APR is a report on the performance of schools and school corporations (districts) in your area. The goal is to provide information regarding the progress schools are making to help students become college-and-career ready. Where possible, this report contains three years of data to show trends – not just this year’s results. In addition, the State Average is also shown for comparison purposes. There are additional indicators that are available on the Indiana Department of Education’s Web site ([compass.doe.in.gov](http://compass.doe.in.gov)), including data broken out by different student subgroups, such as race, gender, income level and special education.

The data in this report have been supplied by the Indiana Department of Education and local school corporations. The report provides the most recent data available.

Indiana educators and citizens have developed higher academic standards for all students. These standards are necessary to prepare Indiana students to be successful in life, whether they go directly to higher education or to the workplace. The scores for ISTEP+ are listed under each school to reflect student progress toward those standards. **Note: In 2014-15 Indiana transitioned to a new, more rigorous college-and-career ready standards and a new statewide assessment to measure these standards. Therefore ISTEP results are not comparable to previous data.** For high schools, you also will see graduation rates and the percentage of graduates who plan to go on to college.

Other important data are provided, such as average attendance rates and indicators of school safety, including expulsions and suspensions. Also included is information about your school corporation, such as how much teachers are paid; and the percentage of corporation students who are in special education classes or gifted and talented classes.

## **GOALS FOR EXPENDITURE CATEGORIES**

1. The North White School Corporation shall strive to maintain the percentage for student academic achievement expenditure categories as compared to the other expenditures categories as described in IC 20-42.5-3-6 by taking advantage of all grants possible and by identifying efficiencies in all expenditure categories.
2. The North White School Corporation shall strive to maintain the current levels between the expenditures for the student instruction expenditure categories and the other expenditures as described in IC 20-42.5-3-6 for the next fiscal year. Increases in the student instructional expenditures categories may not be possible due to the uncertainty in enrollment and the decrease in funding.
3. The North White School Corporation shall strive to maintain the current levels between the expenditures for overhead and operational expenditure categories and the other expenditure categories as described in IC 20-42.5-3-6 for the next fiscal year. Increases in the overhead and operational expenditure categories may not be possible due to the unique circumstance that the North White School Corporation is a declining enrollment school corporation but has not declined substantially enough to be able to reduce the cost of maintaining the facilities and other services provided to the educational program.
4. The North White School Corporation shall strive to maintain the percentage for the non-operational expenditure categories as described in IC 20-42.5-3-6 for the next fiscal year by identifying efficiencies in all expenditure categories.
